## LEAGUE CONSTITUTION

### *Incorporating changes (underlined> made at the 2016 AGM*

- 1 General**
- 1.1 In this constitution the words in the first column of the table below shall have the meaning set opposite to them respectively in the second column, if not inconsistent with the subject or context.
- DEFINITIONS**

| "England Squash"      | England Squash & Racketball Limited (formerly The Squash Rackets Association Limited);  |
| "Club Representative" | A person who has been duly authorized by a Club to represent it for the purposes of Rule 4.5 below at general meetings or otherwise to deal with matters relating to the League whose name has been notified from time to time by such Club to the General Secretary in writing (whether by letter or email). |
- 2 Name and Purpose**
- 2.1 The League shall be called the North West Counties Squash League and shall organise a league competition between the squash clubs of Lancashire, Cheshire, Greater Manchester and Merseyside.
- 3 Membership**
- 3.1 Membership shall be open to all squash clubs in Lancashire, Cheshire, Greater Manchester and Merseyside that are affiliated to England Squash.
- 3.2 The procedure for applying for membership is as follows:
- 3.2.1 An Application must be made to the General Secretary before 1st July in any calendar year for admission to membership with effect from the playing season starting in or about September of that year.
- 3.2.2 The Affiliation fee as per Rule 14 of the Rules must be sent with the application.
- 3.2.3 The Committee will consider the application, and, if considered appropriate, accept it.
- 3.3 Applications made after 1st July and before the start of the season ahead may be accepted at the Committee's discretion for that season, but in this case a late entry fee per team will be payable, the amount to be determined by the Committee. New Clubs shall normally start in the lowest division unless they make successful application to the Committee for commencement in a higher division.
- 3.4 Associate Membership shall be open to squash clubs, affiliated to England Squash that lie outside the boundaries of Lancashire, Cheshire, Greater Manchester and Merseyside.
- 3.5 Associated Members are required to apply for membership each year before 1st July. The Committee will decide on each application individually. Associated Members, who have completed 10 years of continuous membership in the League, will be granted full membership rights and will not have to apply for membership each year.
- 3.6 The Committee shall have the power, if at any time in its discretion it considers that the interests of the League require it, to suspend or terminate the membership of any Club subject to confirmation at the next General Meeting. At such General Meeting the Club must be allowed to offer an explanation of its conduct verbally or in writing and, if two-thirds of the Clubs present vote for the suspension or termination as appropriate, the membership of such Club will immediately be either suspended for such period as may be approved by the General Meeting or terminated. The voting at any such general meeting must be by ballot if not less than 5 Clubs present at that meeting so demand. The Committee may exclude from the League until such General Meeting is held any Club whose membership it has decided should be suspended or terminated.
- 3.7 Each Club must pay affiliation fees due to England Squash by the due date. If a Club's affiliation fees are overdue at the start of a season or become overdue at any time during a season, the Committee shall have the power to deduct 5 points per team per match from the start of that season or the date on which those fees become overdue until in either case they are paid. In addition, if a Club's affiliation fees are overdue at the start of a season, that club may not be allowed to take part in the League.
- 4 General Meetings and Other Meetings**
- 4.1 An Annual General Meeting shall be held during the months of May to September in each calendar year. General Meetings may also be called at any other time by the Committee or at the request of three or more Clubs.
- 4.2 Notice of the Annual General Meeting shall be sent in writing (which may be by letter and/or email) to all member clubs no later than 21 days before the meeting is due to be held together with an Agenda containing any proposals which the Committee considers appropriate or which have been sent by Clubs to the General Secretary at least 8 weeks before the date of the Annual General Meeting. If possible, the date of the Annual General Meeting will be set provisionally at the previous year's Annual General Meeting. If a Club is not represented at the Annual General Meeting, a penalty to be fixed by the Committee may be levied.
- 4.3 Notice of an Extraordinary General Meeting shall be sent in writing (which may be by letter and/or email) two weeks in advance of the meeting to all Clubs together with a statement of the business to be transacted.
- 4.4 Items not on the agenda sent out to Clubs before a General Meeting may be taken at the discretion of the Chairman but may not include any proposals for altering the Constitution or the Rules.
- 4.5 Each Club shall have one spokesman and one vote only at a General Meeting. Clubs not able to send a representative may submit their views and votes in writing (by letter and/or email) in advance to the General Secretary so as to reach him no later than 48 hours before the meeting is due to begin. Clubs shall not have a vote until they have played at least one season in the League.
- 4.6 The Annual General Meeting shall elect the President, Vice Presidents and the Honorary Legal Advisor.
- 4.7 Officers and Officials of the League are indemnified to a maximum of £1 m against legal liability and claims for costs and expenses arising from injury or death to participants occurring during League matches, events or activities which are under the control of the League.
- 4.8 The Annual General Meeting shall appoint a suitably qualified Auditor. The Annual Accounts of the League shall be laid before the Annual General Meeting.
- 4.9 Before the start of the season the General Secretary will send to all Clubs notice of the time, date, and place of a meeting ("Captains' Meeting") to explain to Clubs the arrangements for the coming season and to deal with any other administrative matters relating to that season. Each Club shall send at least one team captain to that meeting to ensure as far as possible that each Club is aware of such arrangements or matters. If a Club is not represented at a Captains' Meeting, a penalty to be fixed by the Committee may be levied. Whenever possible, a Captains' Meeting will take place on the same day as but immediately following an Annual General Meeting.
- 5 Committee**
- 5.1 The Officers of the Committee shall be elected at the Annual General Meeting and shall continue in office until the following Annual General Meeting. The Committee shall consist of a Chairman, Treasurer, General Secretary, Match Secretary, up to 5 ordinary members, one representative from each division or section of a division (as appropriate), and one county representative from each of Cheshire, Lancashire and Merseyside. In the event that not all positions on the Committee are filled at an Annual General Meeting or a vacancy occurs before the next Annual General Meeting, the Committee shall have the power to co-opt members of the Committee to vacant positions. The President, Vice Presidents and Honorary Legal Advisor shall be ex-officio members. Three members shall constitute a quorum and the Chairman shall have the casting vote. The Committee may form sub-committees for specialised purposes.
- 6 Rules and Administration**
- 6.1 The Constitution and the Rules (which shall apply to all Clubs and all those who play in the League) shall be decided by a General Meeting. Administration and interpretation of the Constitution, the Rules, and the Code of Conduct of England Squash shall be by the Committee. In order to provide reasonable continuity in the operation of the League it is intended that, if it is possible, changes in the number of teams and the rules for promotion and relegation in the higher divisions shall be decided each year for the season next but one ahead.
- 6.2 The Committee shall have the power to investigate any matter arising which in its discretion it considers should be investigated, to decide on all matters that are not specifically provided for in the Rules, and to appoint sub-committees to exercise any of its powers under the Constitution and the Rules.
- 6.3 If at any time the Committee in its discretion considers that the interests of the League require it, the Committee may require any person playing in the League to cease playing for such period as the Committee considers appropriate provided that such player shall first be informed of the nature of the complaint against him or her and the time and place of a meeting of the Committee at which such player must be allowed to offer an explanation verbally or in writing. The Committee may exclude from the League until such meeting is held any player whom it has decided should cease playing. A player who wishes to appeal against a decision of the Committee under this paragraph may do so in accordance with Rule 13.3 of the Rules.
- 6.4 The General Secretary must be informed in writing (which may be by letter or email) of any changes to a Club Representative, either before or during the season, within 7 days of the change taking place.

## LEAGUE RULES

*Incorporating changes (underlined) made at the 2016 AGM*

### 1. DIVISIONS, PROMOTIONS AND RELEGATIONS

- 1.1 There will, where possible, be one first Division, up to three second, up to six third, up to nine fourth, and sufficient fifth Divisions to accommodate existing teams and additional clubs and teams. Each division shall be divided into such sections as the Committee shall decide are appropriate and each section may, where possible, contain up to fourteen (14) teams, each team containing five (5) players. If there are insufficient teams to make up an appropriate number of sections in Division 5, then Divisions 4 and 5 may be combined although consideration will first be given to reducing the number of teams to eight (8) in some or all sections of Division 5 only with each team playing each of the other teams 3 times during a season.
- 1.2 At the end of a season the top team in each section of Division 2 & 3 and the top 2 teams in each section of each lower Division will be promoted. In Division 3, the 2nd placed teams at the end of the season shall take part in play-off matches, to be published before the start of the season, for promotion to the relevant Division 2 sections. The number of teams relegated from each section of each Division will be such number as is required to accommodate:
  - (i) all promoted teams and
  - (ii) any changes to the number of teams in each section of each division.
- 1.3 The overall winners of each division (other than Division 1) will be decided by play-offs between the winners of each section. The dates of the play-offs will be as shown on the Fixture List and the venues will be decided by the Committee.
- 1.4 Promotions and relegations will be subject to the proviso that no club shall have more than two teams in the same section of a division each except in the bottom two divisions where up to 3 teams may be allowed.

### 2. SCORING

- 2.1 The winner of a rally scores 1 point and serves to begin the next rally.
- 2.2 Each game in Divisions 1, 2, and 3 shall be played to 11 points, except that if the score reaches 10-all, the game continues until one player leads by 2 points.
- 2.3 Each game in all other Divisions shall be played to 15 points, except that if the score reaches 14-all, the game continues until one player leads by 2 points.
- 2.4 A tie between 2 players shall be the best of 5 games unless otherwise decided by the Committee.
- 2.5 A team will be awarded one point for each game won; and the team winning the match will be awarded five bonus points. If a team concedes a tie as a walk-over, the other team will be awarded 3 points for that tie as if it had won by 3 games to nil. If any match is conceded as a walk-over, the winning team will be awarded 3 points for each tie plus five bonus points.
- 2.6 Any team playing a player who at the date of the match in question is (i) under 19 and (ii) registered with the League as under 19 will be awarded one extra point per match for each such player.

### 3. EQUAL POINTS

- 3.1 In the event that at the end of a season two or more teams have the same number of points, the teams shall be placed in order by reference to the number of matches won so that the team which has won more matches shall be placed higher.
- 3.2 If any of the teams concerned have also won the same number of matches, those teams shall be placed in order by reference to the number of points scored against them so that the team which has had fewer points scored against shall be placed higher.
- 3.3

- 6.5 Where any team concedes a walk-over, apart from a club's lowest team, the Committee will also decide on any penalty it considers appropriate.

## 7. ELIGIBILITY OF PLAYERS

- 7.1 Any person playing in a league match ('a player') must be a bona-fide member of the club for which he or she plays and must be registered on the League's web site or with the General Secretary or Match Secretary no later than 7 days after the first match in which he or she has played for the club in question. If he or she is not so registered, the team for which he or she has played will be deemed to have played with a missing player and Rule 4.3 will apply.
- 7.2 No player may play more than once in the same league match or in more than one match in any recognised England Squash (S.R.A.) league on the same day. Players playing in Division 1 on a Tuesday night are NOT eligible to play again for a lower team on the Thursday night of the same week.
- 7.3 Any team in Division 1 must play at least three Home Players in each league match. A Home Player shall be defined as a player who, on the date the league match takes place, either
- is eligible to play for Cheshire, Lancashire or Merseyside; or
  - has been a bona fide member of the club which he or she represents in the relevant league match and has also resided either (a) within the County of any club in Division 1 or (b) within a radius of 15 miles of that club in each case for a continuous period of more than 12 months immediately preceding the time at which the relevant league match takes place (such periods for qualification to apply, for the avoidance of doubt, to both membership and residence).
- 7.4 No player may play for more than one club in a league match in any one season without the permission of the General Secretary, the Match Secretary, the Committee or one of the sub-committees duly designated for that purpose.
- 7.5 No player may play in a league match after 31st December in any season without the permission of the General Secretary, the Match Secretary, the Committee or of one of its sub-committees duly designated for that purpose, unless he or she has already played in a league match during that season. This rule will not be applied to a club's lowest team where its application would mean that the team concerned cannot raise five players.
- 7.6 No player may play in the last three league matches of a division or the play-offs for that division unless he or she has played in at least three league matches in that division, or a lower division, for that club earlier in the season. In extenuating circumstances the General Secretary, the Match Secretary, the Committee or any one of its sub-committees can permit a player who does not meet the above criteria to play for a lower team in his/her club during the last three matches of the season, provided that the club's playing order is maintained in accordance with rule 4.
- 7.7 The General Secretary, the Match Secretary, the Committee or any one of its sub-committees shall be entitled to require any player, Member or Associate Member to provide such evidence as may be called for the purpose of establishing, or otherwise, the eligibility of any player to play in any league match.

## 8. NOTIFICATION OF RESULTS

- 8.1 (i) Where a match has been played, both teams must send their scorecards including full details of the results of the match in writing signed by both match captains; and
- (ii) Where a match is a walkover under Rule 6, the team claiming the walkover must send full details of the circumstances of the walkover;
- in each case to the appropriate divisional representative and, in the case of (ii) only, also to the Match Secretary, so as to be received by the divisional representative and, where also required, the Match Secretary within 6 days after the match has been or ought to have been played, unless agreed with either the Divisional Representative and, where appropriate, the Match Secretary. Scorecards in relation only to matches played can be returned on a less frequent basis, when a team is entering its results every week on the website within 72 hours of the match being played. Any team not notifying the divisional representative within the prescribed period may be awarded no points and may be liable to a fine, both at the discretion of the Committee or any one of its duly designated Sub-committees.
- 8.2 If a match is postponed under Rule 5, the appropriate divisional representative must be notified of the postponement before the original date on which the match is to be played and of the rearranged date within 6 days after the original date of the match. If neither team notifies the divisional representative of the postponement of the match before its original date and of the date of the rearranged match within the prescribed period, no points will be awarded to either team and both teams may be liable to a fine at the discretion of the Committee or any one of its duly designated Sub-Committees.
- 8.3 The Committee may relax the timescales prescribed in Rules 8.1 and 8.2 if in its discretion it considers that there are special circumstances relating to any failure to comply with this Rule.

## 9. STARTING TIMES

- 9.1 Clubs must make their courts available from, and matches must commence by 7 p.m. At least three players from each side should be present by this time.
- 9.2 Clubs can agree to start a match at 7.30pm provided that the home club makes two courts available for the duration of the match. At least four players from each side should be present by this time.
- 9.3 There is no prescribed order for the matches to be played in. Once play has commenced, it shall be continuous until the completion of the last tie.
- 9.4 Failure to comply with this rule shall be regarded by the Committee as sufficient reason for awarding points to the other side or imposing a fine or both. In the event of a Club's late arrival every effort must be made to complete the match. No club or player has the right to claim a tie, only the committee can make that decision.

## 10. AVAILABILITY OF COURTS

- 10.1 If a visiting team has to travel more than 20 miles from its club to a home club, the home club should try to make two courts available for the match.
- 10.2 If a visiting team has to travel more than 40 miles from its club to a home club outside the boundaries of Cheshire, Lancashire and Merseyside, the home club must make two courts available for the match.

## 11. MARKING

- 11.1 All matches must be marked. The home team should provide the necessary marking equipment. Unless agreed otherwise by the opposing captains the home team shall be responsible for marking the one (1), three (3) and five (5) strings and the away team the two (2) and four (4) strings.
- 11.2 The appointment of Referees and the fees payable by either the League and/or the Clubs concerned shall be determined by the Committee.

## 12. TYPE OF BALL

A ball approved by the Committee must be used in all matches unless agreed otherwise by the opposing Captains. The home team may use a non-marking variety of approved ball if it wishes.

## 13. APPEALS TO THE COMMITTEE

- 13.1 Any requests to the Committee for a decision on the Rules or any other issues must be made by the Club Representative within seven days of the match or incident to which it relates and must be sent in writing (by letter and/or email) in such form as the Committee may from time to time require, at the same time providing any supporting documents and/or information, to the General Secretary or the Match Secretary with a copy to the appropriate divisional representative provided that the Committee may in its absolute discretion consider any such request notwithstanding that the period of seven days has expired.
- 13.2 The Committee shall decide any questions which may arise under the Rules and which may be referred to it under Rule 13.1 and may (except where the Rules specify the penalty) impose such penalties on a Club and/or individual as it deems appropriate (including, without limitation, the allocation of points and/or the imposition of bans and/or fines) and shall delegate its powers under this Rule 13.2 to a Disputes Sub-Committee which shall comprise not less than 3 members of the Committee and be selected at the first committee meeting after the Annual General Meeting in any year. Other members of the Disputes Sub-Committee may be co-opted during the relevant year as the Committee may decide necessary.
- 13.3 An appeal may be made against any decision of the Disputes Sub-Committee under Rule 13.2 either (a) to the Committee by sending a written request (by letter and/or email) and a fee (which will be set by the Committee at the start of each season) to the General Secretary within 14 days of being notified of the decision appealed against or (b) to England Squash where appropriate in accordance with the Rules or Regulations of England Squash applicable at the time of such appeal. In the case of an appeal to the Committee the Committee shall appoint an Appeal Sub-Committee comprising members of the Committee who were not involved in the decision against which the appeal is made and such Appeal Sub-Committee shall have all the powers of the Committee under this Rule 13 to impose those penalties which it considers appropriate. Where a fee has been paid for an appeal to the League, the Appeal Sub-Committee shall consider, when making its decision, whether or not the fee should be refunded.

## 14. AFFILIATION FEES

- 14.1 Each club must pay to the League before 1st July in any calendar year an affiliation fee per team for the playing season starting in or about September of that year, the amount of such fee to be determined by the Committee. If affiliation fees are paid after 1st July, then additional fees, set by the Committee, shall be payable.
- 14.2 Each team in Division 1 shall deposit with the League prior to 1st July such sums of money as shall be decided by the Committee. Fines and/or fees imposed by the Committee or the Disputes Sub-Committee shall be deducted from this sum and the balance refunded to the teams concerned at the end of the season.

**COUNTY REPORT**

It is no secret that our sport, squash and racketball, has been facing many challenges in recent years. There is so much on offer in the wider world and our sport has to compete for its place among the top sports in the country. We, of course, know it to be one of the best possible sports, but we are in a world where most people don't give it a second thought and some don't even know what squash is. Most school children have never even been in a squash court.

These challenges will continue to be there, but I am pleased to say that in Cheshire there are still committed enthusiasts in many of our clubs, who are doing a lot to promote the sport and to engage with new participants. I want to thank you all for the work that you do and to remind you that you have the backing and support of the county association. It is my hope that we will all know that we are working together and have much that we can share with each other.

While each club is autonomous and independent, you are very much part of this County Association and your representatives have been elected by you to serve on the committee. We are not self-appointed and have to be elected or re-elected each year. Cheshire is particularly fortunate that we have a committee full of talented people and I want to personally thank each of them for the work that they have been doing on your behalf. The reports show how much they have been doing and without their time, their dedication and their enthusiasm, Cheshire Squash would not have the good reputation that it enjoys in the country.

Inter county championships: I want to thank all the players young and old, men and women, boys and girls who have represented Cheshire. It is a great example of a sport being available to all ages. The highlight once again has been the Ladies Team which, for the fourth year in five has become Inter County Champions. Congratulations to the team - Laura Mylotte, Jess Davis, Olivia Howell, Kirsty West and Annie Openshaw-Blower.

We now have a permanent Trophy Cabinet. We are grateful to Warrington Sports Club for allowing it to be placed here. Cheshire Squash has had a long association with this club, which has been the host of countless championships, senior and junior, countless fixtures and countless training sessions, and, of course, countless committee meetings. With its location in the centre of the county, it is the right place. It is good to note that many other clubs have been supportive of Cheshire Squash and its activities. Alderley Edge have once again been hosts for the Closed Championships and Bowdon Squash Club has been the centre of much of the junior programme, but we are also grateful to the other clubs which have been part of the Junior Grand Prix events. We would like to ask you, if you don't do so already, whether you would offer us court time free as part of your club's support for Cheshire Squash.

You will appreciate that costs of running the sport seems to get higher each year and we have few income streams. England Squash gives us a small rebate according to the number of courts and members declared in clubs. We also receive a grant from NWCSL. For everything else we depend on fee income or we try to apply for funding, not always successfully, for particular programmes.

We have taken the decision to continue to invest in our junior development programme as we believe it is right for us as a county. There continues to be good progress. There is another area that we want to focus on, as a county, for the immediate future. The ladies league report that the number of teams competing is not what it used to be. While still the largest ladies league in the country, the decline is symptomatic of ladies sport throughout the country. We need your help in the clubs, a) to get more ladies and girls playing and b) to get more teams playing. In the longer term we would like to see more ladies becoming leaders and coaches. ### COUNTY REPORT

Merseyside has been actively adapting to the changing landscape of squash and racketball, and contributing to the North West Regional Forum – the new organisation which links clubs and counties to ES.

The national emphasis is on developing the sport at grassroots as well as elite level, and Merseyside’s work on junior development is bearing fruit on both fronts, with a growing number of teenagers coming through the coaching programme to figure in NWCSL teams.

Our coaching programme – often working closely with schools – links to a series of reinvigorated graded and junior team events which feature players from across the county and beyond.

One of the star products of the county’s development programme is Patrick Rooney, the reigning European Under-19 champion, who won his first PSA event – the Madeira International – in June and the under-19 county team made it to the ICC final stage for the first time.

In racketball, Merseyside has national champions at under-13 and under-17 levels, and for the first time the British Junior National Racketball Championships were held in the county.

Another major event in the calendar was the return of the European Corporate Games, with the squash competition this time being held at Northern Crosby.

Through the efforts of a small core of dedicated coaches (with the recruitment of more a high priority), the development of talent within the sport looks to be on course despite the continuing funding struggles. The next step is to link the coaching programme even more firmly to the clubs, so that there is a natural pathway for all promising players to increase their involvement and develop their game.
